



MASTER PODCAST GUEST AGREEMENT

CONSENT TO RECORD & DISTRIBUTE

I, _____ (“Guest”), agree to be recorded (audio and/or video) for the podcast *When Words Fail Music Speaks*.

I grant James Cox and When Words Fail Music Speaks LLC the **irrevocable, worldwide right** to:

- Record, edit, and publish my interview
- Use my name, voice, image, and likeness
- Distribute content across all platforms (podcast, YouTube, website, social media, etc.)
- Use excerpts for promotional and marketing purposes

RE-INTERVIEW TOPIC DISCLOSURE (SPECIFICITY REQUIRED)

Before the interview, the Guest has been asked:

“Are there any topics you do not want to discuss?”

The Guest agrees that any restricted topics must be **clearly and specifically identified** prior to recording.

The Guest understands that **general or vague restrictions are not sufficient**, including but not limited to examples such as:

- “My past”
- “My childhood”
- “Growing up”
- “Personal life”

Restricted topics must be defined with **reasonable specificity**, such as:

- Specific events
- Specific time periods
- Specific individuals
- Specific projects, releases, or experiences



GUEST RESPONSIBILITY & WAIVER

The Guest acknowledges:

- It is their responsibility to provide **clear and specific topic restrictions** before recording
- Any topics not specifically restricted may be discussed during the interview
- Vague or general restrictions shall **not be considered valid limitations**

The Guest agrees that:

- They will not hold the Host or When Words Fail Music Speaks LLC liable for discussion of topics that were not specifically identified in advance
- Participation is voluntary, and the Guest may decline to answer any question during the interview

EDITING & CONTENT CONTROL

I understand:

- The podcast may be edited for clarity, quality, and length
- Final content decisions are at the sole discretion of the Host
- Requests for edits or removal after recording are not guaranteed

COMPENSATION

I understand that:

- My participation is voluntary
- No compensation is required unless agreed in writing

RELEASE OF LIABILITY

I release and hold harmless When Words Fail Music Speaks LLC and James Cox from any claims related to:

- Use, distribution, or promotion of the interview
- Statements made during the interview
- Any impact resulting from my participation



GOOD FAITH

The Host agrees to:

- Conduct the interview respectfully and in good faith
- Honor any clearly stated topic restrictions provided before recording

This agreement shall be governed by the laws of the State of South Carolina.
